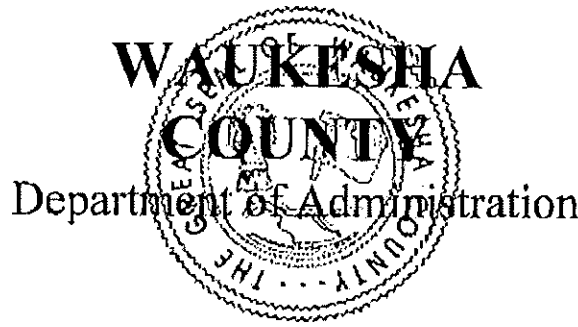

Dear Mr. Perinovic:

The blanket agreement for HVAC Filters, Reference Purchase Order # 96451, is scheduled to expire on 9/14/09. The terms and conditions of the agreement allow for a one-year extension.

The purpose of this letter is to determine whether or not your firm is willing to extend this agreement for an additional one-year period. The agreement may be extended at the same prices or may increase or decrease in accordance with the escalation/de-escalation clause noted in Waukesha County Specification No. 031-03, dated 8/28/08.

This agreement can be extended for an additional one year. Prices will remain the same for the term of the extension.


